Registration papers will be provided to the buyer upon full payment of the puppy. Buyer agrees to register puppy beginning with our Kennel name when choosing their registered name as written on the ASDR paperwork provided.

Breeding rights are given except in not approved situations or occasion. Buyer will pay all shipping and miscellaneous expenses associated with the transport of puppy.

### **HEALTH GUARANTEE**

Seller guarantees puppy is sound and free of disease at time of transfer of said dog/puppy to buyer for a period of three days. Seller will provide records of inoculation and deworming to Buyer. BUYER agrees to have said puppy examined by a licensed small animal veterinarian within 48 hrs from receipt of puppy.

If the puppy is found to be in poor health during this time BUYER will have the option to return the puppy for another puppy of the same sex from the first compatible litter. No money will be refunded unless agreed upon by both parties. Buyer is responsible for the shipping costs of the replacement puppy. We are NOT responsible for any Vet/Medical bills incurred by the buyer. Seller has the right to request a second opinion from a non-associated vet. The health guarantee is void if BUYER neglects to have a veterinarian examine said puppy/dog within the three-day period.

- Our health guarantee does not include any parasite, internal or external, as this is a treatable condition. Only genetic disease or defects will be considered. Each case will be dealt with individually.
- Outland Aussies does not guarantee size, eye color, ear set, conformation, disposition and/or breeding ability of our puppies. We try and give our best guess, however sometimes puppies change

and/or grow larger/smaller than we expect. As with any animals or person, it is hard to know for sure.

- Guarantee does not cover grade 1 or 2 heart murmurs. These can be transient and do not pose a threat to your puppy.
- Outland Aussies does not cover malocclusions – As your puppy grows and develops the teeth are ever changing and it is difficult to predict their final placement.
- Outland Aussies does not cover any condition that is NOT considered life threatening. Conditions not considered life threatening and there fore not covered include but not limited to luxating patella, hernias of any kind, collapsed trachea, etc.
- Breeder will replace (of equal value) with signed statement from a licensed veterinarian for the following:
  1. Failure to pass a veterinary exam within the three-day post purchase exam.
- If the puppy should die from suspected congenital defect within 12 months of its birth date, an autopsy must be performed at the buyers expense by a veterinarian. If the autopsy shows a congenital defect as the reason for death, the seller will provide another puppy of equal value to the buyer. A written statement from the licensed veterinarian must be provided. The guarantee is void in the event of an inconclusive diagnosis.
- Seller shall not be held responsible for the development of disqualifying faults, diseases, viruses or disorders, which are due to the buyers neglect.
- Seller guarantees that puppy has received all recommended vaccines and will provide health records to the buyer.

**GENERAL:**

SELLER RESERVES THE RIGHT TO REFUSE THE SALE OF ANY PUPPY.

- Buyer agrees this contract is not transferable.
- Should buyer choose to break any of the above portion of this agreement, the remainder of sellers guarantee will be considered null and void.
- Buyer understands that there are no guarantees of breeding qualities, show qualities or in final size or disposition of any pet whether expressed or implied. Seller has made no representations as to fitness of purpose and provides no warranty towards fitness for any other purpose.
- Buyer agrees that upon delivery/pickup of puppy by them, that they have carefully examined puppy and accepts puppy as is with regard to physical appearance and breed conformation.

This contract will only be valid while the seller is breeding Aussies. Should the Seller discontinue breeding, this contract shall be void.

This contract is under the jurisdiction of the state of Oklahoma. In the event of any litigation in connection with this contract, the parties mutually agree that the dispute will be settled under the jurisdiction of Oklahoma County, Oklahoma. All parties mutually agree that all legal fees and travel expenses shall be paid by the buyer.

Outland Aussies reserves the right to update and/or modify this warranty at any time with or without notice. This contract may not be altered, modified or rescinded unless agreed in writing by both Buyer and Seller.

I the undersigned buyer have read, understand, and agree with all of the terms and conditions set forth in the "Bill of Sale". I the buyer acknowledge that I have received a copy of this document and accepts full responsibility for the health and well-being of the purchased puppy.
