



## **Outland Aussies Stud Service Contract**

This Stud Service terms and conditions are between the Stud Owner and the Bitches Owner who's signature appears below (herein known as the "Owner").

### **Conditions**

Bitch Owner agrees to:

1. Provide a Negative Brucellosis test done within 30 days of breeding, have up to date shot records, and be free of fleas and ticks.
2. Provide a photocopy of bitch's ASDR registration
3. The bitch must be in good physical condition
4. Pay the agreed breeding fee and either the stud fee or puppy fee
5. If the puppy fee is selected, the owner is required to provide full panel genetic testing of the bitch.
6. Notify the stud dog owner when puppies are whelped and provide litter total of males and females.

The Stud Owner agrees to:

1. Provide a photocopy of stud's ASDR or AKC registration
2. Provide a photocopy of the Full Panel Genetic testing results
3. Have the stud dog in good physical condition
4. Take proper care of bitch while in our care
5. Guarantee an actual tie mating occurs. (If not present – photos will be taken of Tie)
6. Provide the bitch owner with written receipt for the stud service and a record of the breeding dates
7. Approve litter registration promptly after the litter has been whelped

**If the above bitch is not found pregnant – and does not whelp – OWNER must have a Veterinarian's written statement within 70 days from this date. If this happens this contract is null and void and there will be a an additional breeding at no cost.**

### **Stud Service Policy**

1. There is a \$\_\_\_\_\_ non-refundable breeding fee. Fee is payable by Cash, Zelle, or Venmo prior to mating/collection.
2. Estimated semen collection and shipping fee: \_\_\$250-\$300\_\_
3. Payment for Stud Services shall be rendered either by:

- ☐ **Natural Breeding / Side by Side AI Breeding** – If a natural breeding cannot be accomplished due to an uncooperative bitch, and the Bitch Owner desires to proceed with an AI breeding, then a side by side AI breeding will be conducted by a licensed Veterinarian.
  - The additional cost of collection and insemination for a side by side AI shall be the sole responsibility of the Bitch Owner. The Bitch Owner agrees to contact the servicing Veterinarian Clinic with a credit card, and expenses are to be paid directly to the Veterinarian Clinic at the time of service.
- ☐ **Shipped Semen** –
  - All expenses incurred for the collection, preparation and shipment of the semen are the sole responsibility of the Bitch Owner(s). The Bitch Owner is required to contact the servicing Veterinarian Clinic with a credit card, and expenses are to be paid directly to the Veterinarian Clinic at the time of service. The Stud Dog Owner is not responsible for the fresh-chilled, prepared semen once it has left the collection facility.
- ☐ **Puppy Fee** – Will only be given as an option to select females. The fee will be fulfilled by the first selection of a puppy from the resulting litter. If no puppy meets the needs and/or wants of the stud owner, then payment will result in using the Stud Fee amount.

4. If the bitch does not whelp at least two live puppies, the stud dog owner will offer an additional breeding at no cost excluding any veterinary or shipping cost.
5. Owner of the bitch agrees to keep the bitch confined and inaccessible to all other male dogs from the start of her heat cycle until the bitch is fully out of heat.
6. Owner of stud dog agrees to keep the bitch to be bred confined and inaccessible to all other male dogs until the bitch has been bred and returned to her owner.
7. Any and all veterinary fees incurred are the responsibility of the bitch owner.
8. The bitch owner agrees that all puppies resulting from this litter will be properly cared for and placed in proper homes.
9. No puppy resulting from this breeding shall be transferred to wholesale outlets, dog dealers, brokers, humane shelters, laboratories, pet shops or their agents.
10. It is specifically agreed that the stud dog owner is not obligated to sign the application for registration of this litter until the stud fee has been paid in full or, in the case of a puppy fee, the stud owner has possession of the puppy or puppies as agreed. Nor is the stud dog owner required to sign the litter application if any of the conditions in this contract have not been followed or if there is a question as to the parentage of the resulting puppies.

**I have read and understand the conditions of this contract. Any/all fees incurred in the enforcement of this contract shall be borne by the party in default. By our signatures we agree to these conditions and acknowledge having received a copy of this contract.**
